The difficulty here arises from the fact that the compensatory or "homologative" claim has not been brought up for summary judgment. However, the doctrine is available in a direct action, such as this one, for tort damages brought against a county or its employees in their official capacity. *Whistler Corp. v. Sobieski*, *supra*, 132 Colo. at 308, 288 P.2d at 1308. [8] In rejecting the doctrine of continuing violations for the same reasons, we note that *James v. Uvalde County*, *supra*, also rejected the continuing harm theory where the alleged act was committed on August 16, 1972, and the alleged injury occurred July 16, 1973. [9] *H. B. Mann and Wife v. City and County of Denver*, 618 P.2d 789 (Colo. 1980), although not directly relevant to this issue, considered the same statute involved here. Mann and Wife held that an action against a city for compensatory tort damages is barred unless brought within two years of the alleged act or discovery of the injury. [10] The instruction at issue in *Hockersmith v.
